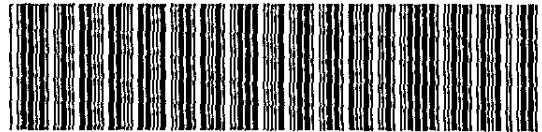

NAME AND PRINCIPAL OFFICE

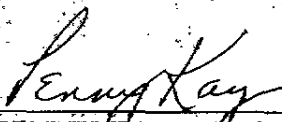
