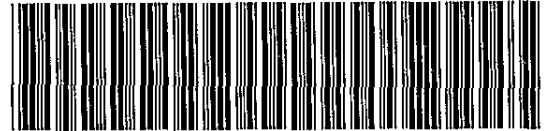

**ARTICLES OF ORGANIZATION
OF
BARRON RENTALS LLC**

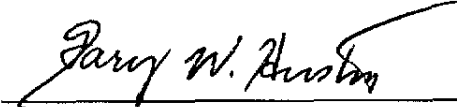
ARTICLE V (REGISTERED AGENT)

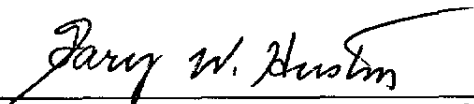
