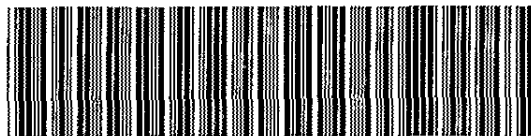

NAME


