

## WISE AND CAPITALIZED, L.L.C. ARTICLES OF ORGANIZATION

The undersigned being a duly authorized representative and Member and acting as the 5 organizer of a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization:

#### ARTICLE I NAME

The name of the Limited Liability Company shall be WISE AND CAPITALIZED L.L.C. (the "Company").

## ARTICLE II DURATION

The period of the Company's duration shall commence on the date of filing these Articles of Organization and shall exist perpetually, unless terminated: (1) in accordance with the Company's Regulations; (2) by the unanimous written agreement of all Members; (3) by the death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member; or (4) upon the occurrence of any other event which terminates the continued membership of a Member. Additional Members may be admitted upon the approval of all of the Members of the Company.

#### ARTICLE VII MANAGEMENT
