including filing these Articles of Dissolution after receipt of the unanimous consent of the Members of the Corporation.



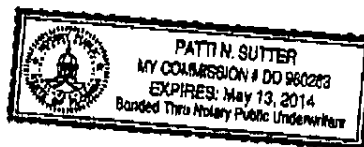
