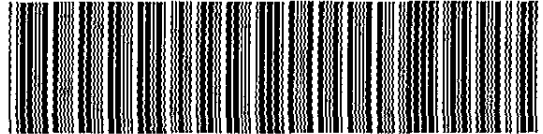

# **ARTICLES OF ORGANIZATION**

**OF**

**GPI VENTURES, L.L.C.**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

## **ARTICLE I - NAME**

The name of the limited liability company shall be GPI Ventures, L.L.C. ("Company").




