ARTICLES OF ORGANIZATION

OF

WELP CHICAGO, L.C.

I, the undersigned natural person competent to contract, hereby organize and form a limited liability company under and pursuant to Chapter 608, Florida Statutes as follows:

ARTICLE 1.

Name of Limited Liability Company

The name of this limited liability company shall be WELP CHICAGO, L.C.

ARTICLE 2.

Period of Duration

This limited liability company shall be in existence for a period of forty years six months from the date of filing these Articles with the Department of State unless sooner terminated by vote of the members.

ARTICLE 3.

Purpose

This limited liability company is organized for the sole purpose of becoming the general partner of a limited partnership to be formed to acquire seventy percent (70%) of the membership interests in and to Dearborn Center, L.L.C. ("Owner"), which is the owner of an office/retail complex known as Bank One Center in Chicago, Illinois.

## ARTICLE 4.

Place of Business and Registered Agent

The street address and mailing address of the initial business office of this limited liability company is c/o Estein & Associates USA, Ltd., 5211 International Drive, Orlando, Florida 32819. The name and address of the initial registered agent of this limited liability company is Boose Casey Ciklin Lubitz Martens McBane & O'Connell, Attention: DEAN VEGOSEN, 18th Floor, 515 North Flagler Drive, West Palm Beach, Florida 33401. This limited liability company shall have the privilege of having offices at other places within or without the State of Florida and within or without the United States of America. This limited liability company may, at its discretion, at any time, change the address of its place of business.

## ARTICLE 5.

Investment in Company

The total amount of cash to be contributed to this limited liability company upon its formation is One Million Dollars (\$1,000,000.00). It is contemplated that there will ultimately be sixteen (16) units at Two Hundred Fifty Thousand Dollars (\$250,000.00) per unit for a total aggregate of Four Million Dollars (\$4,000,000.00) capital contributed to the Company. No property other than cash shall be contributed initially.

Additional Contributions

Additional contributions, if any, will be made as and when agreed to by a vote of at least a majority of the votes of this limited liability company.

## ARTICLE 7.

Additional Members

After the first sixteen (16) units have been subscribed to, additional members may be admitted to this limited liability company upon such terms and conditions as shall be established by a majority of the votes of the then-existing members.

## ARTICLE 8.

Continuation of Business

The remaining members of this limited liability company shall have the right to continue the business of the Company on the death, retirement, resignation, expulsion, bankruptcy or dissolution of any member or upon the occurrence of any other event which terminates the continued membership of a member in this limited liability company.

## ARTICLE 9.

Management

Management of this limited liability company is reserved to ESTEIN MANAGEMENT CORPORATION, who will be one of the members or

owned or controlled by one of the members, or its designee, who shall serve as the manager of this Company until such time as another manager is designated in accordance with the Operating Agreement of the Company. ## ARTICLE 10.

Indemnification of Members and Manager

Except in the case of gross negligence or willful or wanton misfeasance or malfeasance, this limited liability company shall indemnify and save harmless every manager and member of the Company from all costs and expense incurred by him, her or it in connection with the defense of any action, suit or proceeding, whether civil or criminal, in which he, she or it is made a party as a result of having been a member of or manager of this Company.

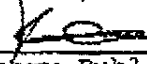

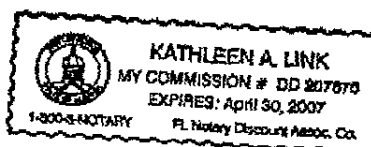

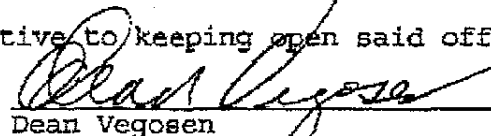
