

### ARTICLES OF ORGANIZATION



## COHEN'S JUDAICA, LLC



The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

#### **ARTICLE 1 - NAME**

The name of the limited liability company shall be COHEN'S JUDAICA, LLC, ("Company").

#### ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 8903 Glades Road, Unit M-1, Boca Raton, Florida 33434 and the mailing address shall be the same.
