**ARTICLES OF ORGANIZATION  
OF**

A Florida Limited Liability Company

**Article I**

**NAME**

The name of the limited liability company is to be TD Properties, LLC

**Article II**

**BUSINESS PURPOSE**

**A. 
**Article VIII**
