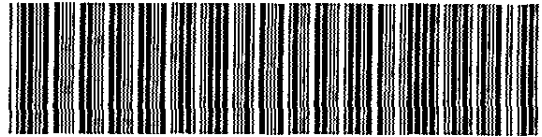

ARTICLES OF ORGANIZATION  
OF  
CRONK DUCH PARTNERS, LLC

The undersigned, being a member or duly authorized representative of a member, desiring to form a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization:

ARTICLE I. NAME

The name of the limited liability company is Cronk Duch Partners, LLC (the "Company").

ARTICLE II. ADDRESS

ARTICLE IV. PURPOSE

The purpose for which the Company is being formed is to engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE V. REGISTERED AGENT AND OFFICE

The Company designates 701 Brickell Avenue, Suite 3000, Miami, Florida 33131 as the street address of the Company's initial registered office, and names Intrastate Registered Agent Corporation as the Company's initial registered agent at that address to accept service of process within the State of Florida.

ARTICLE VI. MANAGEMENT

The Company shall be a manager-managed company. The Company affairs will be conducted, carried on, and managed by one (1) Manager, who will retain

such position until removed and replaced by the Members of the Company as provided in the Operating Agreement of the Company. The Manager will have obligations and responsibilities described in the Operating Agreement. The initial Manager of the Company will be Cronk, Duch, Miller & Associates, Inc. The Manager will serve in that capacity until removed by the Members or until the successor is duly elected and qualified.

#### ARTICLE VII. OPERATING AGREEMENT

The power to adopt, alter, amend, or repeal the Operating Agreement of the Company will be vested in the Members of the Company.
