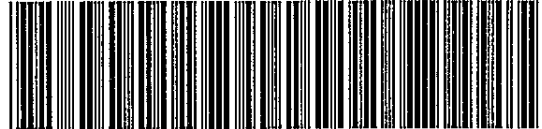

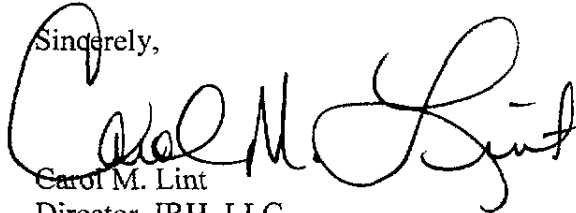

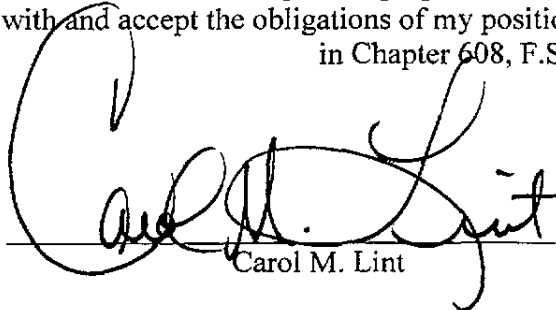

The right of members to admit additional members and the terms and conditions of the admission shall be at the sole discretion of the founding members.

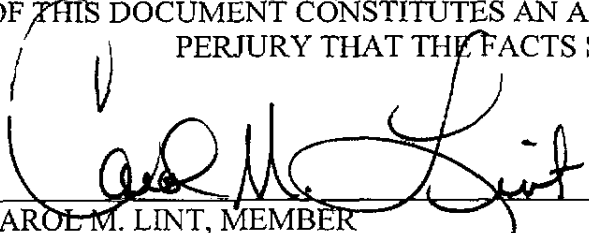
ARTICLE VI – Members Rights to Continue Business:
