ARTICLES OF ORGANIZATION

OF

SPECTRUM, L.L.C.

The undersigned, desiring to form a limited liability company pursuant to Chapter 608 of the Florida Statutes, executes these Articles of Organization.

ARTICLE I.

The name of the limited liability company shall be SPECTRUM, L.L.C.

ARTICLE II.

The period of duration of the limited liability company shall be perpetual.

ARTICLE III.

The mailing address is P.O. Box 2427, Bartow, Florida 33831 and the street address of the limited liability company is 6115 State Road 60 East, Bartow, Florida 33830.

ARTICLE IV.

The name and street address of the initial registered agent of the limited liability company is Charles P. Chritton, c/o Wendel & Chritton, Chartered, 5300 South Florida Avenue, Lakeland, Florida 33813.

ARTICLE V.

The members may admit additional members with the written consent of the managing member, or upon the written consent of all non managing members provided the total number of members shall not exceed ten members without amendment of these Articles.

ARTICLE VI.

The remaining members of the limited liability company have the right to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member, or the occurrence of any other event which terminates the continued membership of a member of the limited liability company.

ARTICLE VII.

This limited liability company shall be a manager-managed company. Norman Duncan shall be the initial managing member of this company and shall have complete authority to manage all the affairs of the company, including with out limitation, the right to convey real property and
