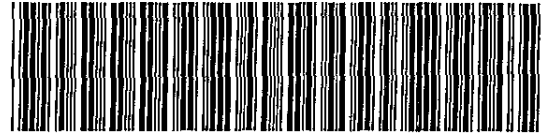



ARTICLE I - NAME

The Company shall be a member-managed company.






