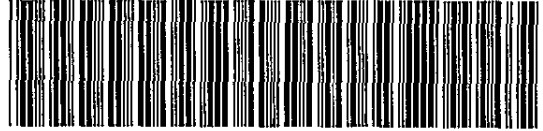



ARTICLES OF ORGANIZATION

FOR

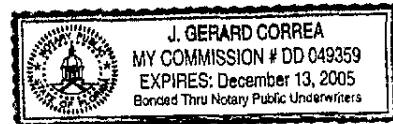
