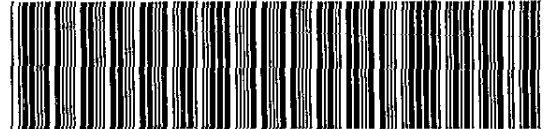

**ARTICLE I
