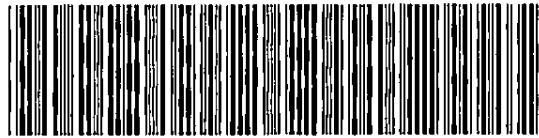

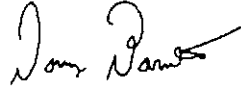
The undersigned, being a manager of MCCI, LLC, a Florida limited liability company (the "**Company**"), desiring to amend the Restatement of Articles of Organization of the Company pursuant to Section 605.0202 of the Florida Revised Limited Liability Company Act (the "**Act**"), states as follows:

1. The name of the Company is MCCI, LLC.
2. The Company is governed by that certain Restatement of Articles of Organization, dated August 28, 2017 (the "**Articles**").
3. The Articles are amended by deleting Article IV in its entirety and inserting the following section in its place and stead:

IV. The powers of the Company shall be exercised by or under the authority of, and the business and affairs of the Company shall be managed by, the Managers.
