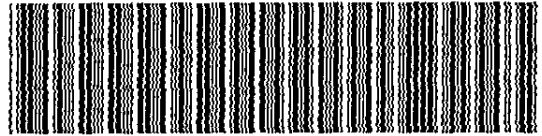


ARTICLE I: The name of the Limited Liability Company is: **Taj Salon, LLC**
