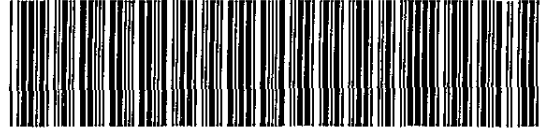

ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be **Precise Development, LLC** (the "Company").

ARTICLE II -- ADDRESS

The address of the principal office of this Company shall be 7050 Northwest 44th Street, #605, Lauderhill, Florida 33319 and the mailing address of the company shall be the same.

ARTICLE III -- REGISTERED AGENT

The street of the initial registered agent of the Company shall be 7050 Northwest 44th Street, # 605, Lauderhill, Florida 33319, and the name of the initial registered agent of the Company at that address is Barbara Gayle.

ARTICLE IV -- NATURE OF BUSINESS

This company may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

ARTICLE V -- CAPITAL CONTRIBUTION

The members of the Company shall contribute to the capital of the Company the cash and/or property set forth in and described in the Limited Liability Company Member Agreement (the "Member Agreement"), if any, and/or in the minutes of the Company (the "Minutes") on file at the principal office of the Company.

ARTICLE VI -- ADDITIONAL CAPITAL CONTRIBUTIONS

Each member shall make additional capital contributions to the Company only on the consent of the members as set forth in the Member Agreement or otherwise upon the prior authorization of a majority of the Members.

ARTICLE VII -- TERM OF EXISTENCE

The Company shall commence its existence on the date these articles of organization are filed with the Florida Department of State. This company is to exist perpetually unless the Company is earlier dissolved as provided in these Articles of Organization.

ARTICLE VIII -- MANAGEMENT

The Company shall be managed by **a manager or managers** in accordance with the Articles of Organization, the Member Agreement, the Regulations adopted by the members for the management of the business and the ordinary and customary affairs of the Company. The Regulations and the Member Agreement, if any, shall determine the manner in which such the Manager(s) are elected and appointed, and may contain any provisions for the regulation and management of the affairs of the Company that are not inconsistent with the law of these Articles of

ARTICLE XI -- INDEMNIFICATION

The Company shall indemnify each Member and/or Organizer of the Company against any and all liability and expenses incurred by him in connection with or arising out of any action, suit or proceeding in which he may be involved, by reason of his being or having been a Member and/or Organizer of the Company to the full extent permitted by the laws of the State of Florida.

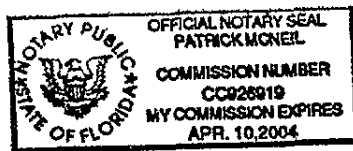
