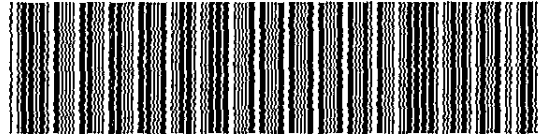


ARTICLE IV: MANAGEMENT OF THE COMPANY


