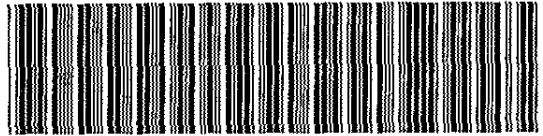


A. Article IV hereby is amended to read:
