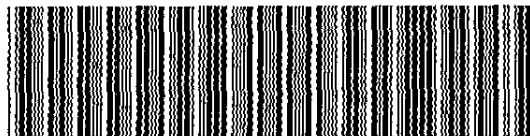

The name of the limited liability company is VALEMONT PROPERTIES, LLC.






