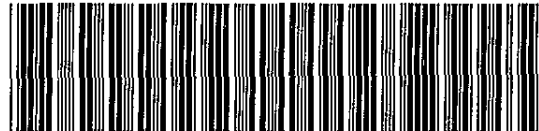

REGISTERED AGENT


