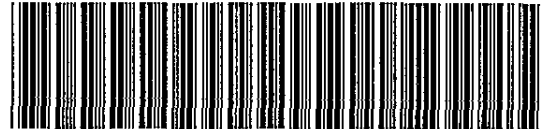



The address of company's principal place of business and mailing address in Florida is 20014 Northwest 262nd Avenue, High Springs, Florida 32643.




