## ARTICLES OF ORGANIZATION OF GARDNER 7<sup>TH</sup> AVENUE, LLC

- 1. Name. The name of this limited liability company is GARDNER 7<sup>TH</sup> AVENUE, LLC (the "Company"), and it shall be formed as a limited liability company under Chapter 693 of the laws of the State of Florida.
