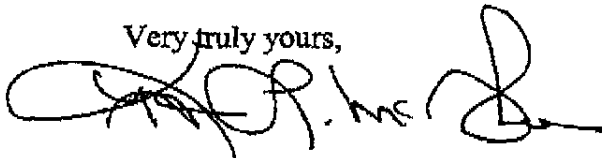

Additional Members may be admitted to the Limited Liability Company upon the unanimous vote of the Limited Liability Company's members.

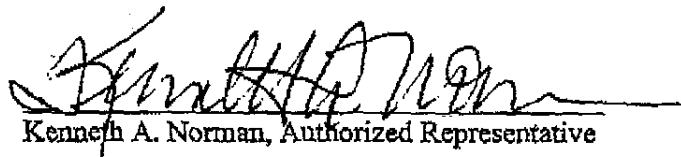
ARTICLE VI - Continuation of Business
