ARTICLES OF ORGANIZATION OF CAR RENTAL ASSOCIATION MANAGEMENT GROUP, ETG.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I. NAME

The name of the limited liability company shall be **CAR RENTAL ASSOCIATION MANAGEMENT GROUP, LLC** (hereafter the "Company"). The mailing address of Company is 3003 South Atlantic Avenue, #15-A1, Daytona Beach Shores, FL 32118. The Company's business address is the same.

ARTICLE II. DURATION
