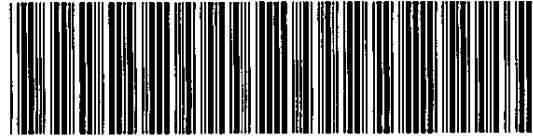

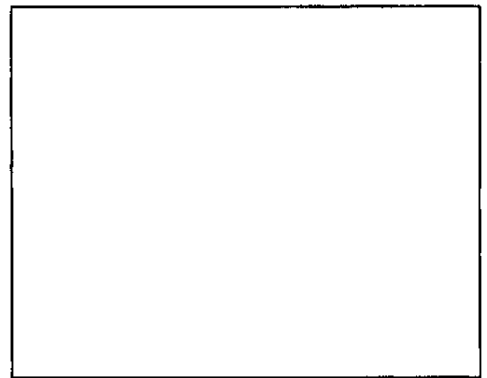

**AMENDMENT TO
AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
OF
RELIABILITY SOLUTIONS, LLC**

Pursuant to the Florida Statutes, Section 608.411, the undersigned members of **RELIABILITY SOLUTIONS, LLC**, a limited liability company organized and existing under the laws of the State of Florida, hereby submit the following:

1. The name of the limited liability company is Reliability Solutions, LLC.
2. The Articles of Organization of the Limited Liability Company were filed in the office of the Department of State of Florida on July 18, 2003, as amended on October 23, 2003; and were amended and restated on May 1, 2008 (as amended and restated, the "Articles of Organization").
3. The Articles of Organization of the limited liability company are hereby amended as follows:


Article 1 of the Articles of Organization is hereby deleted in its entirety, and there is substituted in lieu thereof the following:

"1. The name of the limited liability company is Reliability Solutions Training, LLC, and any and all references to 'Reliability Solutions, LLC' shall hereafter be deemed to refer to Reliability Solutions Training, LLC."
