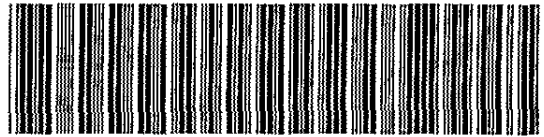

ARTICLES OF ORGANIZATION
OF

ARTICLE I - COMPANY NAME

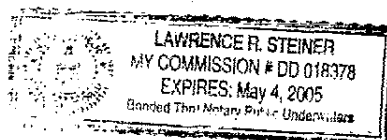
