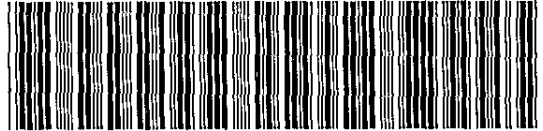

ARTICLES OF ORGANIZATION FOR A LIMITED LIABILITY COMPANY

The undersigned being authorized to execute and file these articles hereby certifies that:

ARTICLE I - Name

The name of the Limited Liability Company is Po Seng Tong , L.L.C.

ARTICLE II - Purpose

ARTICLE VI - Principal Place of Business

ARTICLE VII - Effective Date

The effective date of these articles is upon filing.

ARTICLE VIII - Non-Liability

The members and managers shall not be liable for any debts, obligations or liabilities of the Limited Liability Company.


ARTICLE IX - Admission of Additional Members
