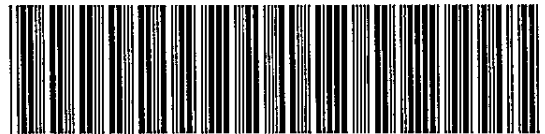

The name of the limited liability company shall be C & P PROPERTIES, LLC ("company").


