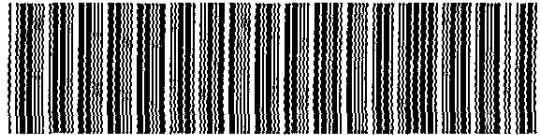

**ARTICLE I - Name:**

The name of the Limited Liability Company (hereinafter referred to as the "Company") is

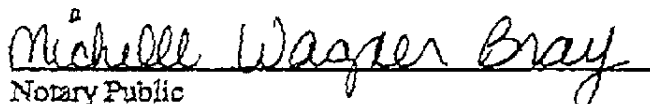

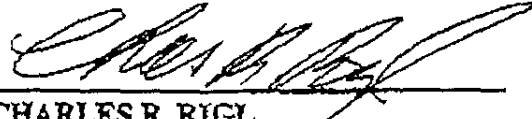
