**ARTICLE I - NAME**

The name of the limited liability company shall be **MANAGEMENT KING LLC** (the "Company").

**ARTICLE II - ADDRESS**

**ARTICLE III - DURATION**

**ARTICLE IV - REGISTERED OFFICE AND AGENT**

Having been named as registered agent and to accept service or process for the above stated limited liability company at the place designated in this certificate, I hereby accept the appointment as registered agent and to act in this capacity. **A. New Members.** As provided in the Operating Agreement, no additional members shall be admitted to the Company except with the written consent of the members owning a majority of their collective interests in the Company, which consent shall not be unreasonably withheld.

**B. Transfer of Membership.** A member may transfer all or a portion of his or her interest in the Company only as provided in the Operating Agreement.

**ARTICLE VII – MEMBERS’ RIGHT TO CONTINUE BUSINESS**

As provided in the Operating Agreement, the Company shall not be dissolved on the death, bankruptcy or dissolution of a member or manager.

**ARTICLE VIII – MANAGEMENT**

The Company shall be managed by a manager in accordance with the Operating Agreement adopted by the members for the management of the business and affairs of the Company. This Operating Agreement may contain any provisions for the operation and management of the affairs of the Company not inconsistent with law or these Articles of Organization.
