ARTICLES OF ORGANIZATION

OF

GREEN SOD COMPANY, L.L.C.

SHIP MEZ In accordance with the provisions of the Florida Limited Liability Compania Act, Florida Statutes, Chapter 608, (the "Act") the undersigned, sole organizer of a Florida limited liability company, and an authorized representative of a Member of the Company hereby files these Articles of Organization:

ARTICLE I -- NAME

The name of the limited liability company is GREEN SOD COMPANY, L.L.C. (the "Company").

ARTICLE II -- ADDRESS

The mailing address and street address of the principal office of the Company in the State of Florida is 3020 Hartley Road, Suite 100, Jacksonville, Duval County, Florida 32257.
