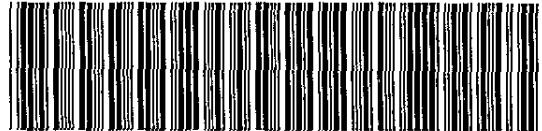





6. There are no suits, pending or threatened, against Fisher Thomas, LLC, in any court, state or federal.


