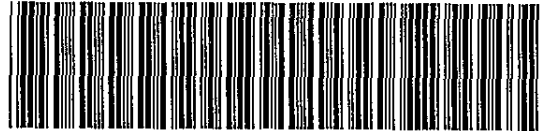

ARTICLES OF ORGANIZATION
OF
TRI-TRAINING FOR WOMEN, LLC

The undersigned, being authorized to execute and file these Articles of Organization for the purpose of forming a Florida Limited Liability Company pursuant to Chapter 608, Florida Statutes, hereby certifies as follows:

ARTICLE I
NAME

The name of the limited liability company (hereinafter referred to as the "Company") is TRI-TRAINING FOR WOMEN, LLC.

ARTICLE II

MANAGEMENT

The Company is to be managed by certain members designated as managers. Each initial managing member is identified as follows:

ARTICLE VI
ADMISSION OF NEW MEMBERS

Members of the Company have the right to admit new members. Additional members may be admitted on the unanimous written consent of the existing members. Existing members shall determine the amount and nature of contributions by new members at the time members are admitted.


ARTICLE VII


ARTICLE VIII
