The undersigned, as an authorized representative of Contrarian Cash Fund, LLC, executes these Articles of Organization for the purpose of forming a limited liability company, pursuant to Section 608.407 of the Florida Limited Liability Company Act (the "Act"), and does hereby make, subscribe and file these Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company (hereinafter referred to as the "Company") is Contrarian Cash Fund, LLC.

ARTICLE V - PURPOSE AND POWERS

The Company shall be managed by the members.

ARTICLE VIII - LIMITATION ON AGENCY AUTHORITY TO MEMBERS

Pursuant to section 608.4235 of the Act, no member of the Company shall be an agent of the Company solely by virtue of being a member.

**ARTICLE IX - RELATIONSHIP OF ARTICLES OF ORGANIZATION
TO OPERATING AGREEMENT**

If any provisions of these Articles of Organization differ or otherwise conflict with any provision of the Operating Agreement, then, to the extent allowed by applicable law, the Operating Agreement shall govern.
