ARTICLES OF ORGANIZATION

OF

CVW INVESTMENTS, LLC

- 1. Name. The name of this limited liability company is CVW INVESTMENTS, LLC (the "Company"), and it shall be formed as a limited liability company under Chapter 608, Florida Statutes.
