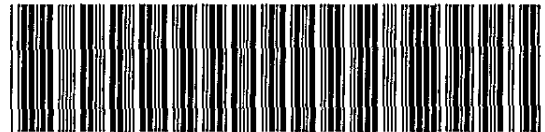

**ARTICLE I
NAME**

The name of this Limited Liability Company is

**ARTICLE II
PURPOSE**
