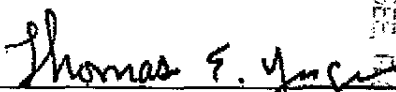
ARTICLE VI**Admission of New Members**

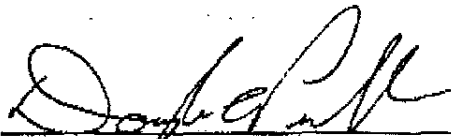
