ARTICLES OF ORGANIZATION

OF

ADVANCED METALS TECHNOLOGY COMPANY, LLC

The undersigned organizer hereby forms a Limited Liability Company under Chapter 608 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the Limited Liability Company ("Company") shall be:

Advanced Metals Technology COMPANY, LLC

ARTICLE II. PRINCIPAL PLACE OF BUSINESS

The address of the principal place of business of this Company shall be 1977 Imperial Golf Course Blvd., Naples, Florida 34110, and the mailing address of the Company shall be the same.

ARTICLE III. TERM OF EXISTENCE




