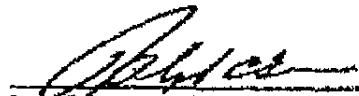
ARTICLE V

MEMBERSHIP CERTIFICATES

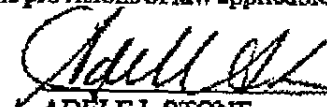

This provision shall not be amended, and no such purported amendment to this provision shall be effective, until all outstanding certificates have been surrendered for cancellation.
