**ARTICLE I.

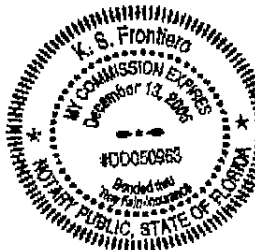
