



3. The date the dissolution was approved: October 24, 2007.


4. A description of the occurrence that resulted in this company's dissolution pursuant to Section 608.441, F.S., is: written consent of all of the members.

BACKGROUND

TERMS

2. **Liabilities.** Prior to making distribution to the members of this Company, the president of this Company shall use the available assets of the Company to pay all Company liabilities.



action of the members of the Company.


