ARTICLES OF ORGANIZATION**OF****BRITCO, LLC**

Pursuant to the provisions of Chapter 608 of the Florida Statutes, the undersigned hereby declares the following provisions as the Articles of Organization of BRITCO, LLC, a Florida limited liability company (the "Company").

ARTICLE 1: NAME AND MAILING ADDRESS

The name of this Company is BRITCO, LLC, and its principal office and mailing address is 2435 U.S. 19, Suite 250, Holiday, Florida 34961.

ARTICLE 2: DURATION

This Company shall exist perpetually, commencing as of the date of acceptance and filing of these Articles by the Secretary of State of the State of Florida.
