**ARTICLES OF ORGANIZATION
OF

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I - NAME

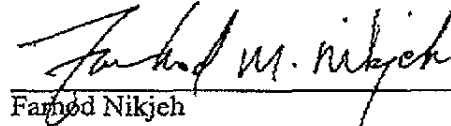

ARTICLE V - OTHER MATTERS

Except as set forth in the regulations, no additional members shall be admitted to the company except as provided in the operating agreement. A member may transfer his/ her/its interest in the limited liability company as set forth in the operating agreement, but the transferee shall have no right to participate in the management of the business and affairs of the limited liability company or become a member unless otherwise permitted by the operating agreement.

The company shall terminate on December 31, 2063, or at such earlier date as provided in the Operating Agreement.
