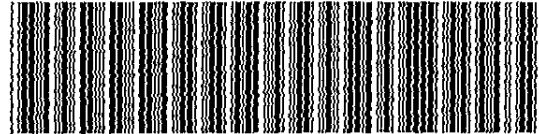

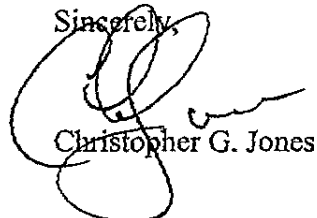

ARTICLES OF ORGANIZATION
of

a Florida limited liability company

ARTICLE I
NAME

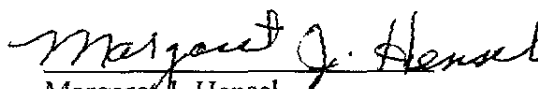

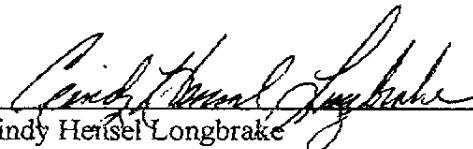
