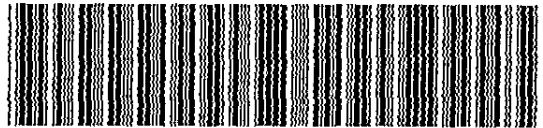

- II. Article V of the Articles of Organization is hereby deleted in its entirety and replaced with the following amended Article which is hereby inserted and adopted in the place thereof:


