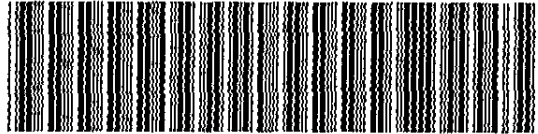



The terms and conditions of the admission of additional members shall be established by the Regulations of the organization as may be amended from time to time.


## ARTICLE VI - MEMBERS RIGHTS TO CONTINUE BUSINESS

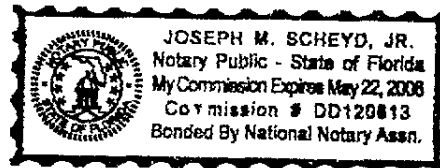
