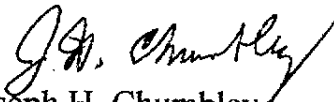

**ARTICLES OF ORGANIZATION  
OF  
ENERGY SOLUTIONS, LLC**

The undersigned, desiring to form a limited liability company under the provisions of Section 608.401 Florida Limited Liability Company Act, as amended, hereby sets forth the following:

Article I    Name. The name of the Limited Liability company is Energy Solutions, LLC.

Article II    Principal Office. The mailing address and the street address of the principal office of the Limited Liability Company is 3900 A 31<sup>st</sup>. Street North, St. Petersburg, FL 33714

Article III    Registered Office and Agent. The post office address of the initial registered office of the Limited Liability Company is located within the City of St. Petersburg at 3900 A 31<sup>st</sup>. 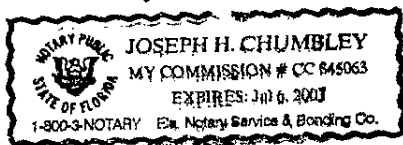
