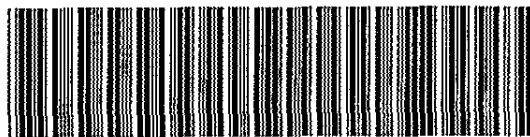

## ARTICLE VII




